Haryana State AIDS Control Society (HSACS) intends to fill following posts for **Opioid Substitution Therapy(OST) Centres** in various districts of Haryana . These posts will be on contractual basis for period up to 31.3.2022 which will be renewed on year to year basis on assessment of performance as per guidelines received from NACO. The remuneration is consolidated and no other allowance is admissible. The first three months will be probation period after appointment. The contract shall be extended by appointing authority only after completion of probation period.
