- Appointed initially for one year which may be extended as per requirement for successive periods of 1 (one) year each considering health and performance of work.

While selecting the candidates for appointment, the Commission will also consider the satisfactory performance/experience of the candidates working in any of the Regulatory Commission, Central Government, State Government, Power Sector Utilities, Statutory body or reputed non Government Organisation and other PSUs. However, the candidates having experience of Regulatory Commission will be preferred.

- 5. Under Bihar Electricity Regulatory Commission (Appointment of Consultant) Regulations, 2014, the appointment shall be treated as Staff Consultant and he will work under the secretariat of the Commission.
