Following are all the general and special instructions for the applicant with respect to filling the application form

- 1. Apply well in advance without waiting for last date of submission of application form.
- 2. Please read the instructions and procedures carefully before you start filling the Application Form and check all the particulars filled up in application form to ensure the correctness of information and attach all documents with the application.
- 3. The candidate should fill all details while filling the Application Form.
- 4. The soft/scanned copy of completed application on the prescribed format along with all self attested scanned photocopies of relevant documents of identity proof/category/domicile/educational qualifications/experience etc., one self attested passport size photograph pasted on the application form must be sent on e-mail id i.e. recruayush@gmail.com on or before office closing hours on 16.08.2021.
- 5. No request for change of any particular on the application form shall be entertained by Department of AYUSH Haryana.
- 6. The Selection shall be made in accordance with Part-II of Outsourcing Policy 06.04.2015 and amended time to time and further instructions upto date.
- 7. Candidates who do not fulfil the qualifications/eligibility conditions on cutoff date, their application shall be rejected. All the Certificates relating to educational qualification/eligibility conditions etc. will be determined with regard to last date fixed to apply applications also called as closing date i.e. 16.08.2021 as given in the advertisement.
- 8. The verification of original documents will be done by Selection committee.
- 9. Candidates are advised to fill their application form carefully such as Name, Father's/Mother's name, Date of Birth and Category, Qualification, marks, obtained passing year, photo, Signature, details etc.
- 10. After final submission of application form, no change will be allowed. Candidate will be responsible for any mistake in the data of application form.
- 11. The application form can be downloaded from the departmental website ayushharyana.gov.in/en/recruitment
- 12. The decision of the Selection Committee in all matters relating to acceptance or rejection of an application, eligibility/suitability of the candidates, mode and criteria for selection etc. will be final and binding on the candidates. No inquiry or correspondence will be entertained in this regard.
- 13. Candidates applying for a post must ensure that they fulfil all the eligibility conditions on the last date of application.
- 14. If on verification at any stage starting from submitting application form till appointment, it is found that any candidate does not fulfil any of the eligibility condition or it is found that the information furnished is false or incorrect, his/her candidature will be cancelled and he/she will also be liable to be criminally prosecuted. This is irrespective of whether the candidate was benefitted by furnishing the false or incorrect information in his/her application.

- 15. A candidate whether he/she belongs to General or reserved category viz. SC, BCA, BCB, EWS, ESM, ESP can submit only one application form for a particular category of post advertised. Submission of more than one application form will automatically lead to rejection of candidature. Candidate shall be considered only against the category against which he had applied.
- 16. Selection Committee reserves the right to call upon any candidate personally along with printed copy of the application form with attached documents original certificates and photocopy of self-attested certificates along with Photo, Identity Proof i.e. Identity Card/Driving License/Passport/Voter Card/Pan Card/Aadhaar Card etc.
- 17. Self attested documents with application form received on prescribed e-mail id before the closing date of submission of application shall be considered at the time of scrutiny.
- 18. Claim of reservation/benefit relaxation etc., if any, shall be admissible to those candidates only, who attach the requisite valid certificate issued by competent authority along with their application in support of their claim and of Haryana domicile.
- 19. Self attested copies of all documents must be attached with application form showing qualification, experience etc. on which basis candidate claim marks.
- 20. The schedule of verification of documents will be finalized after scrutiny of application forms and that will be uploaded on www.ayushharyana.gov.in only.
- 21. Weightage will be given to the candidates who worked as Yoga Coach in Sports Department as per duration of their experience and experience certificate issued by concerned District Sports and Youth Affairs Officer/Sports Department.
- 22. If any candidate is not having Graduation Degree in Yoga but having PG Degree in Yoga then his PG Degree in Yoga will be considered as his basic qualification for the post. No other weightage/marks will be given for this PG Degree as additional higher qualification.
- 23. In case of multiple PG Diploma/Certificate Courses, only the latest Diploma/Certificate will be considered for weightage/marks.
