#### **Terms and conditions:**

- The engagement will be purely on contractual basis, initially for a period of one year which
  may be extended with the approval of competent authority on the basis of satisfactory
  working report and conduct.
- 2. The appointee will be allocated with Accommodation (two-bedroom house) within the campus free of cost.
- 3. The appointment can also be terminated at any time (on either side) by giving one month's notice or by paying one month's salary.
- 4. The upper age limit for making an application for contractual appointment will be 63 years, as on 18.08.2021. The contractual doctor will be eligible to serve IIITDM till he attains 65 years. However, engagement beyond 65 years and upto 70 years could be with the approval of Director IIITDM.
- 5. The appointee will be the medical officer in charge of the Institute dispensary and will provide medical services to the Inmates of the campus. The competent authority reserves the right to assign any other duty as and when required. No extra/additional allowance will be admissible in case of such assignment.
- 6. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Treatment, Seniority, Promotion etc. or any other benefits available to the IIITDM employees, appointed on regular basis.
- 7. The appointee will not be granted any claim or right for regular appointment to any post.
- 8. Only consolidated salary will be admissible. Dearness Allowance, increment and other allowances admissible to the Central Govt servants shall not be admissible.
- 9. The appointment shall be on the whole time appointment of the Institution and shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
