**Terms and Conditions:**

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. The candidate must have minimum qualification of VIII standard passed and those who have passed HSSLC or above shall be ineligible to apply for the said post.
3. The candidate should not be less than 18 years and not more than 40 years of age as on the date of publication of the advertisement. Age relaxation will be as per Govt. norms for reserved categories.
4. Applications should reach the office of the undersigned within 15 days from the date of publication of this advertisement in newspapers.
5. No T.A. /D.A. will be admissible for appearing in interview / viva-voce.
6. Canvassing directly or indirectly will disqualify the candidature.
7. All information regarding date of interview will be intimated through newspaper. The list of eligible candidates shall be uploaded in the Official website of Kamrup Judiciary i.e **www.kamrupjudiciary.com**.
8. The Final Selection will be made on the basis of the marks obtained by the candidates in interview/viva-voce only.
