The pay and allowances that are payable would be analogous to the pay and allowances (87,130-1,10,850 (RPS,2015)) to the post equivalent to the Additional Director of Health services or the pay and allowances being paid to the applicant in his/ her parent department (if the candidate belongs to service other than A.P health service.) In addition to the pay, deputation allowance at the applicable rates issued by the relevant G.O's of A.P state / Govt. of India, D.O.P.T wherever it is applicable.
