2. CONTRACT PERIOD, AMOUNT AND OTHER TRAVELLING EXPENSES

The candidate shall be appointed on Contract basis for a period of one year, subject to satisfactory performance which shall be evaluated by competent authority. Renewal may be possible at Bank's sole discretion in terms of extant policies and rules.

3. CONTRACT AMOUNT AND OTHER TRAVELLING EXPENSES:
