**ORDER**

As recommended by the Selection Committee, sanction is hereby accorded for hiring of operators for ERONET/BLONET operators against their names in Annexure “A” upto 31/05/2022. The hiring of the operators (ERONET/BLONET) will be governed by the following terms and conditions:

1. Engagement shall be purely on hiring basis and will not confer any right to the candidate on the basis of this engagement for regular appointment.
2. Engagement will be on consolidated remuneration of ₹14688.00 (Rupees Fourteen Thousand Six Hundred Eighty Eight Only) per month.
3. The engagement will be upto 31/05/2022 or as per further instructions received from the Chief Electoral Officer at the time of expiry of tenure of engagement.
4. The candidate shall have to join within 7 days from the issuance of this order failing which his/her engagement shall be treated as cancelled without issuing any notice.
5. The candidate will report to the ERO office concerned. If the selected candidate does not perform his/her assigned duty to the satisfaction of the ERO/DEO his/her engagement will be terminated after giving him/her one month notice.
6. In case selected candidate is found creating indiscipline or involved in any illegal activity his/her engagement will be terminated after giving him/her one month notice.
7. If selected candidate intends to give up the hiring engagement he/she shall inform the DEO before month of giving up the assignment.
8. At the time of joining, the selected candidate will submit the following documents (in original) to the ERO:
  - a) Qualification Certificate
  - b) DOB Certificate
  - c) Domicile Certificate
  - d) Physical Fitness Certificate
  - e) Character Certificate issued by the Concerned Police Station.
  - f) NOC from DIC office that the candidate has not availed any loan under any self employment generation scheme.
  - g) An affidavit duly attested by Judicial Magistrate stating therein that he/she will not claim any regularization in the Election Department on the basis of hiring engagement and also stating therein that he/she is not working in any other Government/Semi Government organization/corporation nor is

- registered in any university or organization as a student for pursuing higher studies.
- h) An affidavit duly attested by the Judicial Magistrate stating therein that he/she is not involved in any anti-national activity or any criminal case is pending against him/her in any police station/court of law anywhere and also stating therein that the certificates and any other document submitted by him/her to the DEO/ERO are genuine, true and correct.
- i) If at any point of time, it is found that selected candidate has submitted/provided wrong information/documents, his/her selection shall be terminated without any notice and remuneration paid, if any, shall be recovered from the candidate. The ERO will verify the original documents/certificates of the candidates at the time of their joining and should satisfy himself/herself. In case the officer feels to reconfirm the authenticity/genuineness of certificate/documents, he/she should get it verified from the concerned competent authority, before releasing the remuneration to the candidate.
