2. Qualification for Chairperson & Members of Child Welfare Committee (CWC) as per Rule 16 (3) of Puducherry Juvenile Justice (Care and Protection of Children) Rules, 2017:

Qualification & Experience	A degree in child psychology or psychiatry or social work or sociology or human development or in the field of law or a retired judicial officer. Shall have at least 7 years experience in working with children in the field of education, health, or welfare activities.
Age limit	Shall not be less than 35 years and not more than 65 years of age at the time of appointment.

3. Qualification for Members of Juvenile Justice Boards (JJBs) as per Rule 04 (3) of Puducherry Juvenile Justice (Care and Protection of Children) Rules, 2017:

Qualification & Experience	A degree in child psychology or psychiatry or social work or sociology or human development or in the field of law or a retired judicial officer. Shall have at least 7 years experience in working with children in the field of education, health, or welfare activities.
Age limit	Shall not be less than 35 years and not more than 65 years of age at the time of appointment.

*** If the candidates apply for more than one post, separate application form should be submitted.**

Note: The appointment will be subject to the provisions under Rule 16 & 4 of Puducherry Juvenile Justice (Care and Protection of Children) Rules, 2017. The Chairperson & Member of the CWC and Members of JJB shall be appointed by the Government on the recommendation of the Selection Committee under **rule 91** of these rules.

 - ii. The Chairperson and Members of the CWC and Members of JJB appointed shall be paid at Rs.1,500/- (Including Travel allowance) per sitting as prescribed by Government. No other pay or allowances are admissible
