### **Minimum Educational Qualifications for Assistant Professor**

1. Faculty applicants must have a completed doctoral degree from any of the institutions of high repute such as IIMs/IITs/IISc/NITIE, etc., or other comparable institutions of national reputation in India or abroad with consistently strong academic and research records for Assistant Professors.
2. They should also have a successful track record of teaching, training, research, and publications in reputed and ranked international peer-reviewed journals in their area of specialization.

### **Minimum Experience for Assistant Professors**

A minimum post-doctorate experience of three years in teaching/industry/research in institutions of high repute such as IIMs, IITs, IISc Bangalore, NITIE Mumbai, IISERs, or at an equivalent level in such other globally recognized Indian or foreign institutions of comparable standards as may be decided by IIM Amritsar. The candidate for appointment for the rank of Assistant Professor must have research record commensurate with the rank. New Ph.D., candidates may be considered for contractual appointment up to a period of three years or less, or as a visiting faculty member.

### **Scales of Pay**

1. As per 7<sup>th</sup> CPC and benefits approved by the Board of Governors.
2. Contractual faculty will be placed on an equivalent consolidated remuneration.
3. In addition to the regular pay and allowances, ample research and conference travel support, both domestic and international, teaching assistantships and faculty development funds are available, depending on the performance of the candidate.

### **Service Conditions**

1. The Institute reserves the right to transfer the faculty to any Campus/Centre that it may open at any other location in India or abroad, in future.
2. Recruitment can be considered in employment categories of regular, contractual, visiting capacity or professor of practice. Duration of fixed-term appointment for visiting faculty can be up to 3 (three) years, renewable on a year-to-year basis or as may be decided by the Institute.
3. Apart from teaching at post-graduate and doctoral levels, conducting training and executive education programs, carrying out research of international quality, and management consulting work, faculty should also be willing to take up responsibilities of academic administration and institution building. Thus, faculty are required to contribute to all four pillars of academics – teaching and training, research and publications, service to the institute, and service to the profession.

### **How to Apply and Selection Process**

1. It is the responsibility of the candidate to ensure that they meet the eligibility criteria before applying.

  - b. Cover letter explaining teaching, research, and other interests;
  - c. Recent publications/accepted research papers demonstrating research capability;
  - d. Course outlines for courses taught;

- e. Student feedback or other evidence of teaching effectiveness.
4. Applicants who are shortlisted by the screening committee will be contacted for research presentation and interview.
5. The Institute reserves the right to include in the recruitment process, those suitable candidates, who may not have applied.
6. The institute adheres to the goal of social inclusivity and encourages women and reserved category candidates (SC/ST/OBC) to apply for the posts.

#### **Other Terms & Conditions**

1. Candidates are advised to visit the website of IIM Amritsar regularly for updates. Amendments, corrigenda (if any) will be placed on the Institute website only.
2. The Institute reserves the right not to fill up any / some / all position(s).
3. Applicant should satisfy the experience criteria as on 1<sup>st</sup> September 2021. Candidates who are expecting their degree by the above deadline may also be considered, subject to their completion of the degree. Duration of Ph.D. and academic experience acquired before and during Ph.D. will not be counted for the purpose of experience.
4. Mere fulfilment of minimum eligibility criteria does not entitle a candidate to be short-listed.
5. The Institute reserves the right to restrict the number of candidates to be called for the selection process to a reasonable number based on relevant criteria. The institute reserves the right to recruit faculty members from other sources of recruitment or when a qualified applicant becomes available.
6. The Institute will communicate with only the short-listed candidates.
7. The Institute reserves the right to conduct background checks to verify the authenticity of the candidate's application.
8. No correspondence from applicants shall be entertained.
9. Canvassing in any form, either directly or through networks, will be a disqualification.
10. The Institute will not be responsible for postal delays.
