The staff will be appointed for two and a half years (on contract) or up to the duration of the project, whichever is earlier. Initially the contract will be given for a period of six months, which will be extended up to, the duration of the project based on the satisfactory performance..

Educational qualification and essential skills:

- B. Tech. in Civil Engineering with 55% aggregate marks or 6.5 CGPA.
- Candidate should have desirable construction of RCC structure experience.
- Candidate must be able to read both architectural and structural drawings and familiar with IS Codes, site management, quality assurance checks etc.
- The candidate should have at least 3-5 years of experience in the construction industry. **The minimum 1-2 years of QA/QC of plumbing work is preferred.**
- Age limit is 35 years for general category and for SC/ST/OBC/ Women/PH age limit may be relaxed as per GoI norms.
