Online Applications are invited from the candidates fulfilling the prescribed conditions stipulated in this notification for engagement of 4103 apprentices for imparting training under the Apprentice Act, 1961 and Apprenticeship Rules, 1962.

- Please read all the instructions in this notification carefully and ensure that you are eligible to apply before filling the Online application form available on the RRC/SC webpage of South Central Railway website [www.scr.indianrailways.gov.in](http://www.scr.indianrailways.gov.in)
- For registration Candidates should have a valid Aadhar Number, E-mail ID and Mobile number which has to be maintained till the completion of Engagement process for receiving information/Alerts.
- In case the Candidates do not have a VALID personal e-mail ID and mobile number he/she should create his / her e-mail ID and obtain Mobile Number before applying online application and must maintain that e-mail ID/Mobile Number till the end of Engagement process.
- *Candidates should be in possession of Aadhaar Card at the time of registration. Candidates have to fill 12 digit Aadhaar Card number in the ONLINE application. - 2.1 Number of training slots shown in this notification are provisional and the same are liable to increase or decrease depending up on the actual needs of the Administration at the time of finalization of selection.
- 2.2 **Reservation for PWBD:** There will be a reservation to the extent of 4% for Persons with Benchmark Disabilities (PWBD) i.e., 1% each to VI, HI/HH, LD and MD categories. The reservation provided for PWBD candidates is to be adjusted in the appropriate category viz., UR/SC/ST/OBC to which they belong.
- 2.3 **Ex-Servicemen:** There will be a reservation of 3% for Ex-servicemen and children of Serving soldiers/officers in the following cases:
- Children of deceased/disabled Ex-Servicemen including those killed/disabled during peace time.
  - Children of Ex-Servicemen
  - Children of Serving Jawans
  - Children of Serving Officers
  - Ex-Servicemen
- The reservation provided for the Ex-Servicemen quota is to be adjusted in the appropriate category viz., UR/SC/ST/OBC to which they belong.
- 2.4 The Ex-Servicemen should upload Discharge Certificate and in case of children of Ex-Servicemen/Serving Armed Forces, Service Certificate need to be uploaded for availing 3% reservation.
- 2.5 **EWS (Economically Weaker Section) Reservation:** The candidates applying against the vacancies reserved for EWS must upload valid Income and Asset Certificate issued by competent authority as per **Annexure-F**. In case of non compliance to these stipulations, their claim for reserved status under EWS will not be entertained and the candidature / application of such candidates, if fulfilling all the eligibility conditions for UR category, will be considered under UR vacancies only.
- 2.6 For this Act Apprentice notification, the financial year will be 2021-2022 as the closing date of registration is **03.11.2021**.
- 2.7 The statement showing Trade-wise, Railway Establishment-wise & Community-wise slots notified Annexure-1.
- 3.0 **Educational Qualifications:**
- 3.1 The candidate must have passed 10<sup>th</sup> class examination or its equivalent (under 10+2 examination system) with minimum 50% marks in aggregate from recognized Board and also possess ITI Certificate in the trade notified from the institutes recognised by NCVT/SCVT.



- 3.2 The Candidate should possess the required qualification as on date of submitting online application.
- 3.3 ITI Certificates issued by Institutes affiliated to NCVT/SCVT are compulsory in the relevant trades as under

**Note: Engineering Graduates and Diploma holders are not eligible to apply for apprenticeship in response to this notification as they are governed by a separate scheme of apprenticeship.**

- 3.4 Wards/dependents of Railway employees (as per Pass Rules) can also apply online directly.

#### **4 ELIGIBILITY CONDITIONS:**

- 4.1 **AGE:** The candidates should have completed 15 years of age and should not have completed 24 years of age as on the cut-off date for receiving online applications i.e., **04-10-2021.**
- 4.1.1 **SC/ST/OBC-** Upper age limit is relaxable by **05 years** in case of SC/ST applicants and **03 years** in case of OBC applicants.
- 4.1.2 **Persons with Benchmark Disability (PWBD) :** Upper age limit is relaxed by **10 years.**
- 4.1.3 **Ex-Servicemen:** Upper age is relaxable by 10 years in the case of Ex-serviceman upto the extent of service rendered in Defence Forces. **There will not be any upper age relaxation for the children of Ex-Servicemen or Serving jawans/officers.**

- 4.2 The candidates who want to avail the benefit of reservation of SC/ST must upload Caste Certificate on Central Government format issued by appropriate authority as per **Annexure-A** and the same should be submitted at the time of Document Verification.
- 4.2.1 Similarly, the candidates who want to avail the benefit of reservation of OBC must upload Caste Certificate with Non-Creamy Layer Certificate issued **with in three years from the date of issue of notification** on Central Government format by appropriate authority as per **Annexure-B** and the same should be submitted at the time of Document Verification.



Also, OBC candidates have to upload a Self-Declaration form regarding current status of Non-Creamy Layer as per **Annexure-C**.

4.2.3 The PwBD candidates must upload Disability Certificate in proper format **with 40% or more disability** as per **Annexure-D/E**, whichever is applicable and must be produced at the time of Document Verification.

4.2.4 **EWS (Economically Weaker Section) Reservation:** The candidates applying against the vacancies reserved for EWS must upload valid Income and Asset Certificate issued by competent authority as per **Annexure-F**.

5.0 **MODE OF SELECTION:**

5.1 Ministry of Skill Development & Entrepreneurship is organizing Apprenticeship Mela on 04.10.2021 to engage candidates as Apprentices under Apprentice Act, 1961. This Mela is being organized by RDAT. As per the Railway Board instructions respective AMEs/AEEs of Divisional Jurisdiction are being conducted to participate in the Mela along with nominated staff. The applications received through this Mela will also be clubbed in eligible list for this notification.

5.2 Selection of the eligible candidates for imparting training under the Apprentice Act, 1961 will be based on the merit list which would be prepared taking the average of the percentage marks obtained by the candidates in both 10<sup>th</sup> Class/matriculation [with minimum 50% (aggregate) marks] and ITI examination giving equal weightage to both.

5.3 In case of two candidates having the same marks, the candidate with older age shall be preferred. In case the dates of birth are also same, then the candidate who passed matriculation/10<sup>th</sup> Class exam earlier shall be considered.

5.4 **There will be no written test or viva.**

5.5 **Training & stipend:-** Training will be arranged in accordance with the standards and syllabus prescribed by the Central Apprenticeship Council. The selected candidates will be paid stipend during Apprenticeship at the prescribed rates as per extant instructions.

6 **PAYMENT OF FEE:**

6.1 Once the online application is complete in all respects on <https://scr.indianrailways.gov.in/> i.e., filling up of requisite details and uploading the relevant documents in the online application, the candidate will be directed for payment of application fees.

6.2 Application Fees (Non-refundable) - **₹100/- (Rupees Hundred only)**. Transaction charges for online payment, if any, shall be borne by the candidate.

6.3 **Mode of Payment** Application fees to be paid online through any of the following modes:

(i) **Net Banking of SBI and Internet Banking of other Banks.**

(ii) **SBI ATM-cum Debit Card and other Banks Debit Cards**

(iii) **Credit Cards**

(iv) **SBI UPI.**

6.4 **No fee is required to be paid by SC/ST candidates/Female candidates of all communities/PwBD candidates.**

6.5 On successful completion of the transaction, e-receipt with the data entered by the candidate will be generated which should be printed and retained by the candidate.

7.0 **MEDICAL FITNESS & PHYSICAL STANDARDS:**

7.1 Applicants selected will be required to pass the prescribed Medical Examination as per Rules in force before induction into the Training Course.

7.2 For Persons with Benchmark Disability (PwBD), the maximum Disability is detailed Category-wise & Trade-wise as under:

7.3 PwBD candidates, who want to avail the benefit of reservation must upload a **Disability certificate** issued by a competent authority (i.e. Medical Board duly constituted by the Central or State Government including one specialist in the particular field for assessing disability). Disability certificate should be strictly as per the **Annexure – ‘D’ / ‘E’** whichever is applicable.

8.0 **Training & stipend:** Training will be arranged in accordance with the standards and syllabus prescribed by the Central Apprenticeship Council. The selected candidates will be paid stipend during Apprenticeship at the prescribed rates as per extant instructions.

9.0 **HOW TO APPLY/ STEPS TO SUBMIT ONLINE APPLICATION:**

9.1 Submission of ONLINE APPLICATION is of Four stages: Registration, Personal Details/Education qualification Details/Upload Photo/signature, selection of options and



- payment of processing fee.
- 9.2 Visit the website of RRC/SCR i.e. webpage of South Central Railway website [www.scr.indianrailways.gov.in](http://www.scr.indianrailways.gov.in).
- 9.3 Click on the “**ONLINE ACT APPRENTICE APPLICATION**” link.
- 9.4 Candidate will be directed to **instructions page**. On viewing all the instructions candidate can download detailed notification and **click for registration**.
- 9.5 Candidate has to **enter valid mobile number and E-mail ID** and create own password which has to be used for further future logins. After submission candidate will be sent separate OTPs to the registered mobile number and E-mail ID.
- 9.6 After submission of OTPs candidate will be directed to Application page to enter all personnel details like name of the Community, Date of Birth candidate’s Name, father’s name, Educational /Technical qualification possessed by him/her.
- 9.7 Candidate has to choose their option of priority/preference for the Railway Establishments of South Central Railway for Training. Option of priority/preference once exercised is final and no request for modification will be entertained.
- 9.8 **Candidates should that he/she will be allotted to the opted Railway Establishments only as per the merit. He/she will not be considered for the Railway Establishments for which options are not given. Hence, it is advised to submitted maximum options as per Annexure-1**
- 9.9 The candidate has to **upload recent color photograph. The Image should not be more than 1Mb in size** (not older than three months from the date of application) with clear front view of the candidate without cap and sunglasses should be uploaded. The photo should be only in JPEG format-100 DPI. Employees are advised to bring three copies of the same photograph along with e-Call Letter They are also advised to keep 10 copies of the same photograph for further use.
- 9.10 Candidate may note that RRC may at any stage, reject the application for uploading old/unclear photo along with online application or for any significant variations between photographs uploaded along with online application and physical appearance of the candidate.
- 9.11 After uploading the photograph, candidate has to **upload specimen signature (Image should not be more than 1Mb in size)** and upload required **educational certificates in PDF format (should not be more than 2MB in size)**
- 9.12 After uploading all the required educational certificates successfully click on Preview before submission and check the details entered by you as once the data submitted cannot be rectified,
- 9.13 Candidate has to **click submit button for final submission** of his/her application, after which, if applicable, candidates will be directed to payment gateway as mentioned in para 5.3.
- 9.14 An Application form submitted by the candidate will be displayed. Candidates can download/take printout of the application form submitted. A copy of the same can be preserved by the candidate for future reference.
- 9.15 Candidate may login at any stage for completing the submission process of online application after getting registered by clicking “Existing User Login” in the home page

**NOTE:**

- 9.15.1 Communication with the Candidates will be made through SMS & e-mail only. Candidates are advised to provide only their own Mobile number/ e-mail ID to receive and view such communication.
- 9.15.2 Candidates are advised to preserve/note their Registration Number for further stages of correspondence.
- 9.15.3 Before submitting the application, Candidates should ensure and check the accuracy of all the details filled and relevant certificates uploaded and then press the SUBMIT button for online application. **Application once submitted cannot be modified.**
- 9.15.4 For any query regarding submission of online application, candidates may contact the help desk number provided in the instruction page.



- 10.0 **DOCUMENTS TO BE UPLOADED:** SSC/10<sup>th</sup> Class or its equivalent marks sheet.
- 10.1 Proof of Date of Birth.
- 10.2 Consolidated Marks Sheet of all semesters of the trade (ITI) in which applied/Provisional National Trade Certificate indicating marks
- 10.3 National Trade Certificate issued by NCVT or Provisional National Trade Certificate issued by NCVT/SCVT.
- 10.4 Community Certificate for SC/ST (as per Annexure-A) and for OBC (as per Annexure-B & C) wherever applicable should be uploaded.
- 10.5 EWS Certificate as per Annexure –F, if applicable.
- 10.6 Disability Certificate in case of PwBD candidates (Disability Certificate in proper format for 40% or more disability) to be uploaded. However, Annexure-D/E whichever applicable, must be produced at the time of Document Verification (DV).
- 10.7 Discharge Certificate/Serving Certificate in case of candidates applied against Ex-Servicemen quota.
- 10.8 *Note: Production of original documents as stated above, at the time of DV is mandatory, without which they will not be allowed to be considered for training.*
- 11.0 **Invalid applications or Cause of rejection of applications:**  
Candidates are requested to read instructions thoroughly before submitting the ONLINE application. Otherwise, their applications will be rejected on any of the following reasons or on any other valid reasons.
- 11.1 Not possessing the prescribed qualification 10<sup>th</sup> Class and ITI for the relevant trade.
- 11.2 Date of Birth wrongly filled
- 11.3 Uploading Black & White photo or photo with cap, wearing goggles, disfigured, unrecognizable or scanned/Xerox copy.
- 11.4 Scanned Signature in Block/Capital Letters.
- 11.5 The community of the candidate is wrongly mentioned in the application form.
- 11.6 Marks of 10<sup>th</sup> & ITI is wrongly mentioned in the application form.
- 11.7 OBC certificate not issued by the Competent Authority
- 11.8 Any other form of irregularities as observed and considered as invalid by RRC/SCR.
- 12.0 **OTHER CONDITIONS:**
- 12.1 The decision of the Railway administration in all matters relating to eligibility, acceptance or rejection of the applications, mode of selection and allotment of Division/Workshop etc. shall be final.
- 12.2 No correspondences for engagement will be entertained.
- 12.3 Canvassing in any form will disqualify the candidature and no correspondence will be entertained in the matter.
- 12.4 Before applying, the Applicants should ensure that he/she fulfils the eligibility and other criteria. If erroneously engaged, such Applicants shall be summarily dismissed / **TERMINATED** without notice at any stage.
- 12.5 Candidature of the Applicants shall be cancelled if he/she fails to produce the required original testimonials for verification or any other discrepancy noticed.
- 12.6 The Railway administration does not undertake any responsibility for sending reply to the Applicants not selected or not called for. No correspondence in respect of the application submitted shall be entertained or replied by this office to any individual or organization.
- 12.7 The Railway administration will not be responsible for any inadvertent/printing error.
- 12.8 No daily allowance / conveyance allowance or travelling allowance will be paid to the Applicants called for Document Verification.
- 12.9 After selection for engagement, request of Applicants to change the Trade / Division / Workshop will not be entertained. They will be posted within the jurisdiction of the concerned Division / Workshop only.




- 12.10 Applicants will be trained only for the Trade in which they have been selected.
- 12.11 Applicants selected for training will not be allowed to withdraw from training except for reasons, which are beyond their control.
- 12.12 Those who willfully absent themselves for training are liable to refund the whole cost of their training as well as the amount paid as stipend as determined by the Central Apprenticeship Advise.

**CANDIDATES ARE ADVISED TO VISIT THE WEBSITE OF SOUTH CENTRAL RAILWAY (RRC-WEB PAGE) REGULARLY FOR ALL UPDATES.**

- 13.0 The selected candidates shall execute a contract of Apprenticeship under the Apprentices Act, 1961 and if such a candidate is a minor, his Parent/Guardian shall execute the prescribed contract.
- 14.0 The Apprentices shall be governed by the provisions of Apprentices Act, 1961 and Apprenticeship Rules, 1962 as amended from time to time and such other Railway Rules and Regulations applicable to them.
- 15.0 ***The obligation under The Apprentices Act, 1961 on part of the Railways is to provide training only and not to absorb the trained Apprentices. Hence, the candidates will have no prescriptive right for regular absorption/employment in Railway service on completion of the training.***
- 16.0 In case an Apprentice discontinues the apprenticeship training and fails to fulfill the obligations as per his contract without valid reasons, he shall have to refund the stipend paid to him, the cost of training and such other costs that may be determined under the Rules by the Railway Administration. The decision of the Railway Administration in this regard will be final and binding.
- 17.0 Administration reserves the right of allotment of Railway Establishment for training to the finally selected candidates.
- 18.0 **Applications received other than ONLINE will not be entertained.**
- 19.0 **LEGAL MATTERS:** Any legal matter arising out of this Employment Notice, shall fall within the legal jurisdiction of Hyderabad city only.

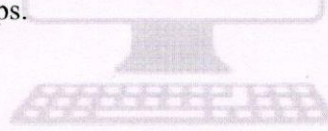
